Artists:

Open to all artists, NLAPW members and non-members, over the age of 18. Men are welcome to enter this show.

Media Accepted In This Show:

The following media may be submitted:

- Impasto, such as oil, acrylic and encaustic.
- Media under glass, such as water media, acrylics, mixed, drawings, graphics, photography, computer art.
- Three dimensional, including sculpture and assemblage.

Judging and Awards:

Art will be judged in one category of Fine Art. Awards are: Best of Show, First Place, Second Place, Third Place and Honorable Mention. Dallas NLAPW will award cash prizes at the artists reception. Any profits from this show will be used to promote the arts, as we are a non-profit organization.

Specifics:

Each artist may enter up to three works. Works should have been completed within the last two years and not previously shown in a Dallas NLAPW show. Work should be original and not created under supervision of a class or workshop. The art committee shall determine acceptance of entries. NLAPW has sole prerogative as to what is shown. No nudes.

- Paintings may not exceed 40"x40". Media under glass sized over 16"x20" must be under Plexiglas. Paintings should be framed and wired for hanging. No sawtooth hangers accepted.
- Three-dimensional works should not exceed 30" in any direction and must be manageable for two persons. You may need to provide a display base for the show.
- Gallery wrapped paintings are acceptable and do not need to be framed.

Entry Directions by Email:

Email jpgs of your work to susan@susanmoss.com. File should be 72 dpi and 576 pixels at its widest dimension. Images other than three-dimensional work should be of artwork only; no frame or background should be visible.

Each image should be labeled without spaces as follows:

YourName_Title.jpg

Example: MaryJones_SummerSolstice.jpg

You will still need to mail your entry form and check payable to Dallas NLAPW to: Carolyn Frenzel, Expressions 2010, 14307 CR 4013, Mabank, TX 75147, postmarked by October 2, 2010.

Entry Directions by Mail:

The art committee prefers email entries, but will accept mailed entry. Mail completed entry form, photographs of work, and check payable to Dallas NLAPW to: Carolyn Frenzel, Expressions 2010, 14307 CR 4013, Mabank, TX 75147. Photographs of work should be minimum 4"x6" and of good quality. High quality prints from a photo printer are acceptable.

Acceptance Notification:

Artists will be able to visit NLAPWdallas.org on or after October 16 to see if their work has been accepted, and for further delivery instructions.

Failure to bring accepted work for display will understandably interfere with being included in future Dallas NLAPW exhibits.

Entry Fee:

Payment is due with a completed entry form:

- Early Entry: \$25.00 for one to three pieces.
- Regular Entry NLAPW member: \$30.00 for one to three pieces.
- Regular Entry Non-member: \$35.00 for one to three pieces.

NOTE: You may reduce your entry fee by \$10.00 if you are a professional woman artist and you submit an application for DALLAS NLAPW membership with your entry. Please request an application from any Art Committee member, or go to nlapwdallas.org and download an application.

Sales:

Sales resulting from this show will be charged a 10% commission. Artist is responsible for collecting and paying sales tax. Any profits from this show will be used to promote the arts, as we are a non-profit organization.

Liability:

Dallas Branch NLAPW will provide special care for entries but will not be held responsible for any loss or accidental damage that may occur.
